You can also apply for payment of government and social insurance office service group life insurance at spv.se/ansok-tgl.

We pay compensation from government and social insurance office service group life insurance to husbands, wives, registered partners, domestic partners and children. Exceptions may be made where specific beneficiaries have been appointed. The estate may also receive compensation from occupational group life insurance in the form of assistance with funeral expenses.

In the application, you can indicate that you would like SPV to obtain the *Death certificate and relatives report (Dödsfallsintyg med släktutredning)* from the Swedish Tax Agency. Otherwise, you will need to submit a death certificate and relatives report yourself. You can request this from the Swedish Tax Agency by calling 0771-567 567.
